# **Terms of Reference**

- 1. The purpose of the Culture, Tourism and Sport Board is to engage and develop a thorough understanding of the issues within its brief and how legislation does or could affect councils and their communities. The Board will provide strategic oversight of all the LGA's policy and improvement activity in relation to tourism, sport, the licensing of regulated entertainment, digital media and cultural services including heritage, museums, libraries, archives and the arts, in line with the LGA priorities.
- 2. The Culture, Tourism and Sports Board's responsibilities include:
  - 2.1 Ensuring the priorities of councils are fed into the business planning process;
  - 2.2 Developing a work programme to deliver the business plan priorities relevant to their brief, covering lobbying, campaigns, research, improvement support in the context of the strategic framework set by the Improvement & Innovation Board, events and linking with other boards where appropriate;
  - 2.3 Sharing good practice and ideas to stimulate innovation and improvement;
  - 2.4 Representing and lobbying on behalf of the LGA including making public statements on its areas of responsibility;
  - 2.5 Building and maintaining relationships with key stakeholders;
  - 2.6 Involving representatives from councils in its work, through task groups, Commissions, SIGs, regional networks and mechanisms; and
  - 2.7 Responding to specific issues referred to the Board by one or more member councils or groupings of councils.

# 3. Boards may:

- 3.1 Appoint members to relevant outside bodies in accordance with the Political Conventions; and
- 3.2 Appoint member champions from the Board to lead on key issues.

# Spending Review and 2015/16 Culture, Tourism and Sport Work Programme

# **Background**

- 1. The purpose of the Culture, Tourism and Sport (CTS) Board is to provide strategic oversight of all the LGA's policy and improvement activity in relation to the visitor economy, the arts, heritage, libraries, museums, sport and physical activity. The Board also works closely with other relevant LGA Boards on shared priorities. In particular, the Community Wellbeing Board to support the role of culture and sport promoting better health, the People and Places Board in relation to the broadband rollout and the Community Safety Board in relation to gambling and regulated entertainment which is also the responsibility of the Department for Culture, Media and Sport (DCMS).
- 2. Against the backdrop of the new Government's priorities, and a Spending Review that is expected to deliver another tough settlement for local government, austerity, reform and devolution will continue to be key drivers for the CTS Board. In particular, with greater flexibility over the scope of devolution deals, we expect more places in the medium to longer term to explore opportunities to devolve some of the tourism, culture, heritage and sport funding and functions currently administered by the DCMS national agencies. This will likely be a key area of focus for the Board's relationship with the agencies.
- 3. Since the general election, DCMS Ministers have set out a policy agenda that aims to achieve a step-change in grassroots sport participation, re-balance the visitor economy away from London and transform the digital connectivity of England's public libraries. Most of the activity in support of these policy areas is led and funded locally, so DCMS will need to work closely with local government in order to achieve their ambitions. This presents Members with an opportunity to ensure that national policy enables, rather than frustrates, local activity and that councils and their partners have the necessary freedoms and flexibilities to lead these policy areas.

# **Government Spending Review 2015**

- 4. The LGA has published its core submission to Government's Spending Review 2015. 'Spending Smarter' builds on our 2015 conference publication, 'A Shared Commitment' to make the case for local government's role in balancing the nation's books while improving public services and the local economic environment.
- 5. 'Spending Smarter' states that since 2010, councils have dealt with a 40 per cent real terms reduction to their core government grant. In adult social care alone, funding reductions and demographic pressures have meant dealing with a £5 billion funding gap. Public polling has shown that roughly 80 per cent of those surveyed are satisfied with local services and that more than 70 per cent of respondents trust councils more than central government to make decisions about services provided in the local area a trend that has been sustained during the last five years.
- 6. Key recommendations include:

- 6.1 Enable wider integration of social care and health services to deliver savings and improve outcomes; and implement a single place-based budget approach for delivering all local services through a Local Public Services Fund as part of at least five devolution deals.
- 6.2 Promote growth and productivity by accepting the case for further devolution of powers and funding including devolution of, or local influence over, more than £60 billion of growth, skills and infrastructure funding over the Spending Review period.
- 6.3 Help councils adequately resource and deliver high quality public services by transforming the business rate mechanism and providing a four year local government finance settlement.
- 6.4 Help councils focus on driving efficiency and value for money through an assessment of the impact of unfunded cost burdens that core council budgets are going to face over the Spending Review period.
- 7. Our core submission is also supported by a small number of themed papers, including on fire and rescue, adult social care, and prevention, not all of which have been made public at the time of writing. The paper on prevention, included separately with this pack, makes the case for a prevention transformation fund by examining evidence currently available. This includes physical activity programmes. The paper is intended to be the start of a conversation with Government that will continue up to the Spending Review and beyond. Members are invited to consider how the Board's work programme could support this conversation.

# **Leadership Board policy commissions**

- 8. As part of the recent member-led review of governance, the LGA Executive and Leadership Board have been asked to commission work from our Policy Boards where a clear corporate priority has been identified or where an important policy issue straddles more than one Board.
- 9. The Leadership Board met in July 2015 and agreed the following remit for the commissioning of policy work from Boards on behalf of the LGA leadership:
  - 9.1 The Leadership Board's commissioning is related to the most important (current and future) issues for LGA membership.
  - 9.2 The issues commissioned cover the terms of reference of more than one Board.
  - 9.3 There will be a limited number of corporate commissions, no more than five.
  - 9.4 Boards will continue to set policy priorities based on their specific terms of reference. These will be reported back to the LGA Executive.
- 10. The following cross-cutting areas of work were agreed and are being commissioned from relevant Boards in 2015-16. Specific Boards have been have been asked to lead this work as indicated below. Lead Boards will be having detailed discussions

about the projects at their first meetings of this Board cycle. All policy Boards are invited to consider their contributions to the four projects. The devolution and health and wellbeing projects will be of particular interest to CTS members.

- 10.1 Devolution and future shape of local government (jointly led by City Regions and People and Places). It is likely that this work will focus on supporting councils to develop and implement bespoke devolution deals, including governance, the evidence base for devolution, and working with Whitehall once the Cities and Local Government Bill has been enacted.
- Housing (led by the Economy, Environment, Housing and Transport Board), will include a focus on addressing housing need, building on the LGA's leadership of this debate.
- 10.3 Finance (led by the Resources Board) will be driven largely by the outcome of the Spending Review and will look to build on our successful Future Funding Outlook work.
- 10.4 Promoting health and wellbeing (led by the Community Wellbeing Board). Continued moves towards an integrated health and care system remains at the top of councils' and the Government's agenda, and getting these new arrangements right for councils and citizens remains a significant opportunity for the LGA. This work should: draw on the wider role of other local services such as schools, children's services, the fire service, public health, housing, transport and leisure; and play in promoting wellbeing across the life course and keeping people physically and mentally healthy, in work, and in their own homes. It should raise the profile of social care as an equal to the NHS, and build a business case for council-led investment as part of a much wider integrated approach to improve health outcomes and address health inequalities, as well as keep pressure off the NHS and other expensive services. This work should also consider the role of citizens and communities in supporting themselves and each other and promoting resilience and independence.
- 11. With these considerations in mind, Members are invited to discuss the draft work programme for the coming year. In particular, views are sought on the issues that are covered, the anticipated impact of the Board's work influencing national players and supporting councils, and the relative balance between the different priorities.
- 12. The work programme can be delivered within available resources, but Members are asked to bear in mind that adding substantially to the work programme will mean not doing some of the projects currently suggested. It is also inevitable that the sector will look to the Board for leadership on a number of significant issues that will be topical over the next year.

- 13. In addition, Ed Vaizey MP, Culture Minister, has announced that DCMS will develop a Culture White Paper covering four themes: the role that culture plays in creating places where people want to live, work and visit; how people engage with culture; building financial resilience in cultural organisations; and working with cultural organisations to promote Britain abroad. DCMS will shortly launch a digital discussion platform to give others the opportunity to shape the White Paper. Although details are to be finalised, responding to the consultation is likely to form a cultural policy strand in the Board's work programme.
- 14. A number of cross-cutting themes will be evident throughout the Board's work. In particular, the outcome of the Spending Review will frame how Members take forward the work programme, there will be a communications element to all of the projects outlined above, and Members will want to ensure that we are well positioned to advance our arguments with Ministers and the DCMS agencies through a regular programme of Chairs' meetings.

# A New Government Strategy for Sport: Consultation Paper

# **Background**

- On 4 August 2015, the new sports minister, Tracey Crouch MP launched A New Strategy for Sport: A Consultation Paper. The Minister felt the previous sport strategy ('Game Plan' published in 2002) was now outdated and in need of renewal. A major driver for this has been the decline in adult participation rates since the 2012 Olympic and Paralympic Games.
- 2. The new Sports Strategy covers 10 themes:
  - Participation
  - Physical activity
  - Children and young people
  - Financial sustainability
  - Coaching, workforce and good governance
  - Elite and professional sport
  - Infrastructure
  - · Fairness and equality
  - Safety and wellbeing
  - International influence and major sporting events
- 3. The sport strategy has incorporated the 2015 Conservative Party manifesto promises on sport and physical activity, which includes reference to the Government committing to work with local authorities, Football Association and the Premier League to invest in artificial pitches in 30 cities.
- 4. The consultation closes on **Friday 2 October 2015**. The responses received will inform a new sports strategy that will be published later in 2015.
- 5. The LGA's submission is an opportunity to position councils and local partners as leading the most effective and value for money whole place approaches to achieving a stepchange in participation rates that also maximises the links to better health and wellbeing, economic growth and stronger communities.

### Key messages

- 6. CTS Lead Members may want to highlight the following key messages in the LGA submission:
- 7. Councils have seized the opportunity to integrate physical activity into public health policy and actively promote health and wellbeing. Not only are councils the biggest public sector investor in physical activity, but they have a deep understanding of their communities that enables them to target physical activity opportunities and encourage participation. Through their wider leadership of place, councils can also harness the contribution of the local public, voluntary and private sectors to ensure that the right

physical activity opportunities are offered to as many people as possible.

- 8. The funding available for local services, including sport, may shrink by 46 per cent by 2020. Given these financial constraints, councils are working innovatively to share services and keep costs down. There is also a strong case for Sport England to rebalance grassroots sport funding away from national interventions and towards councils and their local partners who have a proven track record of leading effective and efficient approaches to increasing participation in partnership with health, schools, voluntary organisations, National Governing Bodies and the private sector.
- 9. It is estimated that there are 440,000 full time sports related jobs (2.3 per cent of all jobs) and 20 per cent of all volunteers are involved in sport. Councils are among the largest employers of sports staff and support thousands of volunteers through training, advice and sporting opportunities. Councils should be at the forefront of initiatives aimed at upskilling staff and volunteers to improve governance and coaching available to participants.

# Sport strategy themes and potential local government responses

- 10. Within the 10 themes of the government's sport strategy, there are a number of key challenges that councils can assist in overcoming. The challenges and the suggested headline LGA response are listed below:
- 11. How to address the recent decline in the number of people that regularly take part in sport and deliver a long-term sustainable increase in participation
  - 11.1 Strategy statement The latest Active People Survey (APS) 9 (April 2014-March 2015) results have shown that 36 per cent of the population aged 16 and over participated in sport at least once a week. This was a decline of over 200,000 people compared to the previous survey. There are variances in participation rates between groups: Men (41 per cent), Women (31 per cent), 16-25 year olds (55 per cent), 26 and over (32 per cent), Ethnic Minority (38 per cent), Disabled people (17 per cent), Socio-Economic groups 1-4 (39 per cent) and Socio-Economic groups 5-8 (26 per cent).   - 11.2 Local government response The majority of grassroots participation occurs on council/local authority owned facilities and council spending on sport and recreation amounts to just under £1 billion per annum, which makes councils key players in any initiatives to drive up participation rates. Councils are signing up to Sport England's 'This Girl Can' campaign and using Sport England's Insight tools such as the 'Active People Interactive Tool', which is enabling councils to identify and address the wider barriers to participation, such as cost, lack of transport or time, poor facilities and staff capacity. The LGA and Sport England support councillors to develop their leadership of change and innovation through a very successful Leadership Essentials Programme, which has supported over 150 councillors.
- 12. How to ensure that funding goes to those who can best deliver results

- 12.1 Strategy statement Government provides a significant amount of funding through Sport England to get more people playing sport. Sport England has its own strategy to direct this funding, with a combination of direct funding to National Governing Bodies (managed through individual Whole Sport Plans) and grants to individual bodies. However, this model has not brought about the long term, sustainable increase in participation that the government and Sport England hoped to see.
- Local government response Sport England's latest strategy 2012-17 is 12.2 investing £1billion in the following areas; sport in educational settings (25 per cent), NGB investment (38 per cent) and local projects (37 per cent). Out of the 46 NGBs funded by Sport England, only five NGBs (Athletics, Boxing, Cycling, Mountaineering and Table Tennis) have shown a statistically significant increase in participation rates between APS 1 (2005/6) and APS 9 (2014/15). The highest participation sports were: Swimming (2.5 million), Athletics (2.2 million), Cycling (2.1 million), Football (1.9 million) and Golf (0.7 million). The increase in cycling participation has shown what is possible when local sports networks – led by councils with County Sport Partnerships and equivalents - are embedded in NGB Whole Sport Delivery Plans in a joined-up ladder of participation. Indeed, there is a strong case for re-balancing Sport England funding towards local projects that are proven and efficient approaches to increasing participation. This would be in line with the Government's the devolutionary approach. For example, Be Active is a scheme provided free of charge to all Birmingham residents who live within the Birmingham City Council area. It is estimated that Be Active has nearly 140,000 active users per year. Every £1 invested in Be Active generates on average £21.3 in benefits.
- 13. How to specifically target the different health outcomes that physical activity can deliver, including how they can contribute to preventing or treating diabetes, obesity, dementia and mental health problems
  - 13.1 Strategy statement Physical inactivity is a hidden killer. It directly contributes to one in six deaths in the UK, the same proportion as smoking. It is the fourth largest cause of disease and disability in the UK. Around a quarter of people in England are classed as inactive. Physical activity can help prevent and/or treat a range of physical and mental illnesses, including cancer, heart disease, strokes, dementia, depression, type 2 diabetes and can contribute to weight management.
  - 13.2 Local government response Councils are leading a whole-place shift away from a system that treats ill-health to one that tackles the root causes and reduces demand for costly health and social care interventions. Since April 2013, the transfer of public health responsibilities to councils continue to offer huge opportunities to further position sport and physical activity within place's health improvement priorities and help to reduce the increasing costs to the NHS. The LGA is calling for the rules around spending the public health grant to be relaxed to allow councils to use the grant as part of wider integration of local services as well as bidding in the Spending Review submission for a Prevention Transformation Fund. The Fund

could prevent problems arising in the first place, prevent dependency on the health and social care system, or – when targeted at the right groups of people – prevent the escalation of problems which become worse for individuals and more costly to the taxpayer.

- 14. How to raise awareness of the UK Chief Medical Officers' guidelines on physical activity (2.5 hours of moderate intensity activity over a week for adults) and ensure interventions enable more people to meet them
  - 14.1 Strategy statement All four of the UK's Chief Medical Officers (CMOs) have set out some clear guidelines about how much physical activity is required. Adults should be doing 150 minutes of moderate physical activity per week (or 75 minutes of vigorous activity), in bursts of 10 minutes or more. Guidelines are different for older people and children. However, these guidelines are not currently well known or understood by some within the medical profession, let alone the population at large.
  - 14.2 Local government response With councils responsible for the public health of its population, communication with residents to increase awareness of the amount of physical activity required to achieve health benefits is one of the ways that this can be achieved.
- 15. How to ensure that schools, community sports clubs, central government and its agencies work together as effectively as possible to maximise opportunities for young people to take part in sport and be physically active
  - 15.1 Strategy statement School sport policy is owned within Government by the Department for Education. There are also links to be made across national government most closely with DCMS and Department of Health as well as local government. The Primary PE and Sport Premium, worth over £150 million a year and paid directly to primary schools, is the only ring-fenced school funding for a curriculum subject.
  - 15.2 Local government response Councils are often the main sport provider in a locality and therefore have an overview of all sports provision within their area, as well as a deep understanding of young people's needs. This means councils are in a unique position to broker collaborative working between schools, voluntary groups, local sports clubs and business to ensure that appropriate physical activity opportunities are offered to as many young people as possible.
  - 15.3 It is also the case that funding for tackling physical inactivity is currently fragmented across different government departments and agencies, each with its own application and monitoring requirements. Government should consider streamlining the funding streams for a more efficient system that maximises the amount of resources that reach the frontline.
- 16. How to ensure that the significant amounts of money at the top level of some sports, primarily generated from the sale of TV rights, also benefit grassroots

### sport

- 16.1 Strategy statement There are a number of sports that have benefited from lucrative TV deals in recent years. While Premier League football is the prime example, it is by no means the only one. Government would welcome views on the role of those benefiting from lucrative TV rights sales in ensuring that a portion of that income is distributed to support grassroots sport.
- 16.2 Local government response The majority of grassroots football is played on council owned pitches. The CTS Board has recently called on government and football lead bodies to re-invest more of their TV income into grassroots provision and further support good practice between councils and football clubs to increase participation rates.
- 17. How to ensure that the sports workforce has the skills it needs, including soft skills as well as technical ones, to address the challenges set out in the sport strategy
  - 17.1 Strategy statement The Government has committed to 3 million apprenticeship starts by 2020 and the sport and leisure sector can play a huge part in delivering this. It is the whole front-line workforce that plays a role in creating the right environment for individuals to feel that sport and activity are for them. It is therefore crucial that all staff in a role promoting physical activity, including those in direct contact with the public, have the skills and the continuous professional development they need.
  - 17.2 Local government response Councils are among the largest employers in the sports sector and can assist the government in getting more apprenticeships within the sport sector, as well as improving the skill levels of the sport workforce through full devolution of employment and skills funding.
- 18. How government can work with Local Authorities to ensure that where they jointly invest in sporting infrastructure already this can be as effective and efficient as possible
  - 18.1 Strategy statement Government is committed to decentralisation and empowering local communities and local authorities to make the best and most suitable decisions to reflect local need. Sport England have worked very successfully with a number of local authorities to co-fund new infrastructure projects, including many that have sought to house a number of different services within the same facility. Government would welcome views on how it can most effectively and efficiently align its infrastructure investment with that of local authorities.
  - 18.2 Local government response –The LGA has called for more devolvement of decision making and funding to local areas, which would improve sports connectivity and avoid duplication of facility and service provision. Councils have a proven record of managing public sector infrastructure more efficiently and co-locating services (for

example, councils such as Leeds have co-located leisure and social care services).

- 19. How to ensure an appropriate legacy for the UK from the hosting of major sporting events including how they can boost the economy and volunteering as well as participation
  - 19.1 Strategy statement Since London 2012, the UK has continued to be a global home for major sporting events. To date, over 70 Major sporting events have been secured for the UK. The government want to ensure that major sporting events are set up to drive the maximum possible legacy benefits in terms of sport participation and also economic and community (including volunteering and culture) benefits.
  - 19.2 Local government response A large part of the success of the London 2012 Games and more recently the 'Tour de France' cycling stages held in the UK was as a result of local government playing a significant role with partners to organise, promote and inspire community involvement, which boosted economic growth through increased tourist visits. They are therefore an important part in securing the legacy from these events.

# **Next steps**

- 20. The following activity will be undertaken to develop the LGA response to the strategy consultation:
  - 20.1 Continue to liaise with councils, CLOA, other partners and LGA colleagues to develop our key messages and response to the challenges highlighted in the consultation document. We also understand that DCMS is keen to hear practical and specific proposals about how the removal of central barriers could help councils and partners do even more to encourage activity (September).
  - 20.2 Amend submission in the light of CTS Board discussion and send to CTS Lead Members for clearance (21 September).
  - 20.3 Submit final LGA response to DCMS (2 October).

# Item Decisions and actions Action

# 1 Welcome and minutes from the last Board meeting

The Chair welcomed Members to the Board meeting.

Apologies for absence were received from Cllrs Terry O'Neill, Alyson Barnes, David Phillips and Greg Smith. Cllr Colin Organ substituted for Cllr Smith and Cllr Jane Edbrooke substituted for the Labour Group.

The Chair accorded thanks to Doreen Stephenson who stood down at the local elections and was very involved in the Board's work, in particular speaking at the Culture Leadership Essentials Programme. He also accorded thanks to Apu Bagchi who was an Independent substitute Member.

The Chair congratulated Cllr Peter Golds who was awarded a CBE in the Queen's Birthday Honours List. He also thanked Iain Varah whose tenure as Chair of CLOA ends this week and the Chair looked forward to welcoming and working with Mark Allman, the new Chair. Mark is the Head of Sports and Active Lifestyle at Leeds City Council.

The minutes of the meeting held on 3 March 2015 were <u>agreed</u> as an accurate record.

# 2 The Policy and Funding Landscape for the Arts- report attached

The Board welcomed Laura Dyer (Executive Director, Arts Council England) and Paul Bristow (Director Strategic Partnerships, Arts Council England) to the meeting.

Laura Dyer gave an overview of ACE funding streams and current programmes. Post-general election and ahead of the Spending Review, Members agreed it was a good opportunity to take stock of where we are on arts funding, the challenges and opportunities for further collaboration.

The Board were keen to explore the opportunities for the arts that might arise from devolution and consider what this might mean for how ACE



works with councils. Members also highlighted how we can support the arts to be bigger players in commissioning conversations and strengthen our narrative on how the arts can help to tackle costly health and social pressures. Members expressed their strong support for the joint Cultural Leadership Essentials Programme, which is funded by ACE.

### **Decision**

The Board **noted** the report and welcomed the presentation.

Officers to reflect Members' key points in Spending Review activity.

# The new Government and Culture, Tourism and Sport- confidential report attached

The Chair noted that the new Government set out its legislative programme for the next five years in the Queens Speech on 27 May 2015 and published major Bills including the Cities and Local Government Devolution Bill. There would be an Emergency Budget on 8 July 2015 with an expected Spending Review in the autumn 2015. The report to the Board summarised the wider political and financial context for culture, tourism and sport and suggested areas of focus for the coming weeks and 2015/16.

The Chair advised the Board that he had written to Ed Vaizey MP, reappointed as Culture Minister, and Tracey Crouch MP, new Sport and Tourism Minister, and would be meeting Tracey Crouch on 7 July. Crosscutting work with other LGA boards was important, particularly in relation to the LGA's DevoNext campaign.

Board members felt that the tourism should be at the forefront of the Government's agenda. Devolution deals would develop quickly in the next few weeks and months and there were potential opportunities for culture and tourism.

The Chair requested that Board members should be able to put forward comments between Board meetings to Laura Caton and the Member Services Officer.

### **Decision**

The Board <u>agreed</u> the priority areas for 2015/16 as contained in the report.

# 4 Evaluation of the 2015 Culture, Tourism and Sport Annual Conference and Looking Ahead to 2016/17- report attached

Over 150 delegates attended the LGA's annual Culture, Tourism and Sport Conference in Durham on 3 and 4 March 2015, organised in partnership with the Chief Cultural and Leisure Officers' Association. The report to the Board summarised the delegate feedback and updated



Members on plans for the 2016 Conference. Thanks were again accorded to Cllr Henig and Durham County Council for their excellent support. It was **noted** that evaluation had shown a very high level of delegate satisfaction with the conference in all respects.

Leicester as a venue for the 2016 Conference was welcomed and it was hoped that there would be an opportunity for delegates to visit areas of interest in the locality, including the Richard III visitor centre and the Curve theatre. In addition, Leicester would be the Rugby World Cup host city. It was <u>noted</u> that Leicester and Leicestershire had a rich heritage. Cllr Pain offered to work with officers in his capacity as Leader of Harborough District Council and as a member of Leicestershire County Council to reflect the partnerships between the city, county and district councils.

#### **Decision**

Members **noted** the Conference evaluation;

Members <u>noted</u> that the 2016 Conference will be in Leicester on 24-25 February; and

**Noted** that officers were exploring Hull as a venue for 2017.

#### **Action**

Cllr Blake Pain would discuss with officers about the 2016 Conference and how to reflect partnership working between Leicester City, Leicester County and the district councils.

The Board's Lead Members had a very useful update meeting with the Chair of the Task Force, Paul Blantern and Chief Executive, Kathy Settle on 19 May ahead of this Board meeting.



It was anticipated that the Minister Ed Vaizey MP and the Chair would be soon formally review the Task Force's early progress and a further update would be circulated to the Board ahead of the next meeting in September 2015.
