FEEDBACK - Meeting between Sir Merrick Cockell and Lord Green to discuss closer, more strategic relationship between the LGA and UKTI

Date: Tuesday, 25 June 2013, Time: 15:00-15:45

Key Points:

- Economic growth has rocketed up the priority for local government. Every leader is alert to it. Strong evidence of local government's unique role in attracting inward investment and supporting export activity.
- More support is need for local government on this issue. For example, signposting local government (particular senior official and politicians) to understand what the possibilities are within UKTI and where the sensible links are.
- UKTI recognise the value of focusing on local government sector in a more systematic way. This means building capacity at local level to enable local government to both encourage inward investment into areas and assist SMEs within given localities to become exporters.
- English local government is well-regarded amongst its international peers as a strong innovator and exemplar practitioner of local public service.
 For example, planning multi-year financial settlements against significant financial pressure, working on combined authorities, commissioning services and commercialising activities. There is strong potential to convert the export of good practice into potential business.
- The LGA has helped create opportunities in new/emerging markets for UK firms. For example, in Mexico, public budgets are being devolved and public contracts opened up to competition. Mexican local and regional government has approached the LGA (in recognition of UK local government's competence in this area) to help support these new private public partnerships, thus opening opportunities for UK firms.
- LGA also has direct contact with influential senior politicians in new/emerging markets through our local government networks. There is strong opportunity for UKTI to engage and link these into a trade and development discussion.
- As traditional civic twinning agreements evolve in more meaningful commercial partnerships between localities, there is a role to support local areas to help ensure such partnerships are chosen and maintained on the basis of their usefulness to local SMEs and also use local government connections to create or strengthen links with "2nd cities"
- Part of UKTI's remit is to find overseas investment for infrastructure and regeneration projects. There is scope therefore to support local government to specifically identify opportunities' that might interest overseas private equity and sovereign wealth fund managers.
- Public sector co- investment into large infrastructure and regeneration projects (for example through local authority pension fund) provide additional reassurance for these schemes, as evidence that local
