Item Decisions and actions

Councillor Kay Hammond welcomed Members to the meeting, including those newly appointed over the summer. She noted apologies for ClIrs Healey and Shah.

1. Fire Services Management Committee membership and appointments to outside bodies 2013-14

Members **noted** the **Board membership** and **calendar of meetings** as outlined in the paper.

Members highlighted the 16 May date as the Friday before local elections and requested that this meeting be moved to a later date.

Cllr Hammond asked for her apologies to be noted for the FSMC on 15 November and that Cllr Joyce would act as Chairman in her absence.

Officers tabled a revised **Terms of Reference** for the FSMC, taking into account changes in the representation and role of the committee. Members approved this with one amendment to the title of the "Chair of the Employers' Organisation NJC" to become "Chair of the Employers' Side of the NJC for LAFRS". The final Terms of Reference is attached as <u>Appendix A</u>.

The appointments to **outside bodies** for 2013/14 were agreed as follows:

Central Local Partnership Sub Group for Fire (new name TBC) -Cllrs Kay Hammond, John Joyce, Jeremy Hilton and Phil Howson

Members asked if the name of this group could be changed as the current title did not effectively communicate the purpose of the group.

Members noted that this Group has not yet met to date and asked whether appointments should be deferred until it meets. However, Cllr Hammond said that part of this body's role was to act as an emergency group should the need for one arise.

Firefighters' Pensions Committee - Cllr Maurice Heaster

Members approved the priorities set out within the report, with a caveat that flexibility remained in the work schedule for any issues emerging over the course of the year. Members particularly highlighted the potential for a White Paper on the future of the fire service, expected later this year, to influence the FSMC's priorities going forward.

3. Industrial relations

Gill Gittins, LGA Principal Negotiating Officer, gave a verbal update on the latest developments in industrial relations, including the threat of strike action on pensions. In response to a question on formal notice to employers required before strike action could take place, Gill said that at least 7 days prior notice had to be given.

Cllr Hammond asked members to comment on the alternative arrangements they had in place in their own areas in the event of strike action taking place. The following points were highlighted by members:

- In the event of strike action, Fire Authorities would provide cover but members made it clear that they could not provide a full service.
- The message was being communicated locally that any service during such a scenario would not be "business as usual" and the public would be encouraged not to call unless

absolutely necessary.

• Enhanced safety in the home campaigns were being rolled out in advance of potential action.

Members considered the National Employer draft media statement on the strikes and asked about the authorisation process for the form of words. Gill said that the statement had been drawn up by officers and cleared through the political group offices as usual as far as LGA perspective was concerned. The LGA approach to media remained that this is a matter between Government and the FBU. Cllr Hammond emphasised that greater involvement of lead FSMC members alongside Workforce Board colleagues by the political groups was necessary in agreeing LGA statements that FSMC representatives could potentially be asked to comment upon by the press.

Appendix A

Terms of Reference

Fire Services Management Committee

The **Fire Services Management Committee** will report to the Safer & Stronger Communities Programme Board.

Membership

- 1. There shall be representation of each type of fire authority in England (Combined Fire Authorities, County Councils, Metropolitan and LFEPA) on the body together with the Chair of the Employers' Side of the NJC for LAFRS (appointed by the LGA as the majority group).
- 2. The LGA's political group offices will each appoint a fire spokesperson from the Members appointed to the **Fire Services Management Committee.**
- 3. The office holders of the Safer & Stronger Communities Programme Board (or a named substitute) may attend meetings of the **Fire Services Management Committee**.

Role

- 4. At the beginning of each corporate year, in consultation with and approval from the Safer & Stronger Communities Programme Board, the **Fire Services Management Committee** will agree a work programme for the coming year that is consistent with the objectives and priorities of the Board.
- 5. The role of the **Fire Services Management Committee** is to represent as an LGA body the views and concerns of the fire community, ensuring that local circumstances have a voice in the national context.
- 6. The **Fire Services Management Committee** will take the lead on behalf of the LGA on the future direction of the fire and rescue service and improvement within the sector.
- 7. The **Fire Services Management Committee** will take the lead on all other day-to-day issues (e.g. technical or operational matters) affecting fire authorities.
- 8. The **Fire Services Management Committee** will, as required, work with partners and stakeholders on fire issues.
- 9. Where issues have a clear impact on the broader agenda of the Safer & Stronger Communities Board or necessitate the setting of a new LGA policy the **Fire Services Management Committee** will make appropriate recommendations to the Board.
- 10. The **Fire Services Management Committee** will, from time to time, undertake work requested by the Safer & Stronger Communities Board.
