Item Decisions and actions

Action by

1 Health and Social Care Bill: update on progress of health reforms

Cllr David Rogers OBE, Chair of the Community Wellbeing Programme Board, introduced this item which updates members on the progress of the Health and Social Care Bill, summarises LG Group parliamentary activity on the Bill and other current and planned activity related to the health reforms. Cllr Rogers informed members that although more detailed amendments would be announced later in the month, the proposed changes to the Bill maintain local flexibility and strengthen the role of Health and Wellbeing Boards.

On behalf of the LG Group Executive the Chairman thanked Cllr David Rogers and the Community Wellbeing team for their hard work to ensure that the voice of local government was heard at all stages of the Bill's process.

In discussion, Members raised the following key points:

- Members welcomed the proposed amendments to Health and Wellbeing Boards, particularly with regard to the changes which will enable them to refer commissioning plans back to clinical commissioning groups or the NHS Commissioning Board for further consideration, where this is deemed necessary.
- Members expressed some concerns about the Bill's lack of reference to social care integration and the threat to current integrated arrangements between PCTs, councils

and other providers, and supported further lobbying by the LG Group for the clarification on commissioning 'Cinderella services', in particular for local authorities to commission these.

- Members expressed concern with the proposals to separate responsibility for children's health from adult's health, particularly the proposal to transfer responsibility for children's health away from local authorities.
- Members raised concerns that some proposals in the Bill set out extremely short timescales for implementation, which could lead to resource capacity issues for both the NHS and local government.

Decision

The Executive **noted** the current and proposed LG Group activity in relation to the Health and Social Care Bill and the wider health reforms.

Action

 Officers to take forward Members' comments in lobbying activity on the Bill.

2 Local Government Resource Review

Stephen Jones gave a presentation to the Executive which summarises the sector's responses to the LG Group's consultation on the LGRR and sets out our proposals for future steps. Stephen informed members that many councils' responses set out some of the key risks of the current system for local government – that government continue to reduce formula grant, made up largely of NDR, while the yield from business rates continues to grow in line with RPI. No council's response stated that they wanted the current financial system to be maintained and there was a significant appetite for reform.

In discussion Members made the following comments:

 There was broad consensus that although councils should be rewarded if their efforts to grow their local economies succeed, this should be balanced by adequate safeguards for authorities whose local revenue base would not match spending needs, or whose revenue base would not be able to keep pace with spending pressures. However, it was also pointed out that many authorities start with poor

- prospects for growth, and for these councils there needs to be very significant additional support to assist with rebalancing in order to address the gap over time.
- Members agreed that the LG Group should focus on both the short term and long term reform of the local government finance system. Short term proposals should be based upon what is achievable in the current context, but the LG Group should also continue to lobby to extend the tax base of local authorities, as well as seek a consensual framework for alternative ways of investing for infrastructure.
- Members discussed the need for further discussions with businesses and with the Confederation of Business Industry to address any opposition by the business sector to proposals for the relocalisation of business rates.

Officers thanked Members for their comments, which would be used to help shape the LG Group's response to the Government consultation.

Decision

Members **noted** the results of the LG Group's LGRR and **authorised** officers to develop a proposal for localisation of business rates to be launched at the LG Group Annual Conference, subject to clearance by the Leadership Board.

Action

Officers to formulate the LG Group response to the Local Government Resource Review in line with Members' steer.

3 The Localism Bill

Jo Miller introduced this item which updates the Executive on the current status of the Localism Bill and suggested areas for the Local Government Group to continue to lobby as the Bill progresses through the House of Lords. Jo added that there was strong cross-party support for the Bill in the House of Lords and that LG Group lobbying had played a significant role in informing many peers about the key issues in the Bill for local government.

Members agreed with the areas of focus for LG Group lobbying and the Chair thanked all colleagues for their continued work on the Bill.

4 Annual Report of the LG Group Audit and Scrutiny Panel

Decision

Members **reviewed** the first annual report of the Group Audit and Scrutiny Panel.
