1. LGA Campaigns for 2012-2013

Luke Blair introduced a report which set out draft proposals for eight possible campaigns, building on the four broad policy areas agreed at the Board's last meeting.

The Leadership Board agreed six campaigns and made a number of comments which were noted by officers for inclusion in the next stage of development of the campaigns.

Members agreed that each campaign should be sponsored by a member of the Leadership Board and identified one sponsor for each campaign, subject to ensuring a proportionate spread across the groups.

Decision

- agreed six campaigns, set out in the <u>Appendix</u> to this note, along with a named Leadership Board sponsor for each campaign
- **Noted** that the next stage of development would include further work on the titles, objectives and approach for each campaign.

2. Adult Social Care

Councillor David Rogers OBE, Chairman of the Community Wellbeing Board, introduced this item, which summarised the events over the last eighteen months that will culminate with the Spring White Paper. The report also set out suggestions for future activity to maintain momentum up to the White Paper.

Andrew Cozens, Strategic Adviser for Health and Children's & Adult Services, highlighted that the LGA had succeeded in moving Government to a formal recognition that there is a funding gap in Adult Social Care. The LGA was continuing to maintain a lead role on the issue, including holding a roundtable with MPs and speaking at events at both member and officer level. Andrew Cozens concluded that the LGA's goal for Adult Social Care was stability/predictability and transparency.

3. LGA Business plan 2012-2013

Carolyn Downs, Chief Executive, presented the LGA's draft Business Plan for 2012-2013.

In the light of the LGA's reduced budget and reduced staff resources, Carolyn undertook to bring a detailed workplan to the Board's March meeting, mapping staff and budget to the LGA's priorities and highlighting resource pressures.

4. Chief Executive's Monthly Report – February 2012

Carolyn Downs, Chief Executive, introduced her February report to the Leadership Board. The report summarised the main achievements over the past month of each of the nine Boards and the LGA Executive against the business plan priorities, along with performance against key indicators, including membership and budget.

The Chief Executive provided a further update on progress of discussions on the transfer of public health staff between Primary Care Trusts and local authorities.

Stephen Jones, Director of Finance and Resources updated members on current discussions with the Department of Health on public health grant allocations

5. Welfare Reform – impact on local government and the communities they serve

Paul Raynes, Head of Programmes, introduced a report which summarised the key issues, including possible new burdens and proposed mitigating actions for councils and the LGA in the light of the Government's welfare reform agenda.

Paul Raynes said that discussions were continuing in Parliament on Council Tax Benefit (CTB) and Universal Credit (UC). Ministers in the DWP were now acknowledging the experience councils have in working with local people in the delivery of housing and council tax benefit and were now open to councils playing a role in the delivery of UC.

Members made a number of detailed comments which were noted by officers. In particular, Members stressed the important role for the LGA to play in ensuring that local authorities were well prepared to address the issues that will arise from the Bill.

The Chairman stressed the need to provide Government with sound evidence on the effects of council tax benefit localisation and referred to some recent work undertaken by London Councils on the impact of Universal Credit.

Decision

The Leadership Board agreed

- to refer the report for further consideration to the LGA Executive the following day;
- to provide the Executive with evidence on the effects of council tax benefit localisation;

Actions

Group Leaders agreed to raise the issues for discussion at their **Group Leaders** Group meetings prior to the LGA Executive.

Offices to circulate the report and evidence of the effects of **Paul Raynes** council tax benefit localisation to the LGA Executive.

6. A new conduct regime for councils

Paul Raynes, Head of Programmes, introduced a report which set out two illustrative options for the structure and tone of an LGA template code of conduct to be made available for local authorities to use if they wished. The report updated members on the LGA's discussions with other interested groups and sought views on handling questions of conflicts of interests, and possible guidance material to accompany a template code.

The Leadership Board discussed the benefits and disbenefits of each of the two template code options.

Decisions

The Leadership Board

- **noted** the revised timescales for implementation of the new standards provisions and the outcome of the LGA's meeting with stakeholders;
- **agreed**, by majority vote, that both options should be made available to member authorities, in order that they might choose which to adopt or amend as they see fit, to meet their new duties on standards under the Localism Act.

7. National representative body for Police and Crime Commissioners

Helen Murray, Head of Programmes, tabled a draft prospectus setting out the LGA's draft membership offer for Police and Crime Commissioners.

The Chairman of the LGA had held initial discussions with Kit Malthouse, London Deputy Mayor, on the LGA's offer, had written to the Policing Minister, Nick Herbert and had met Mark Burns-Williamson, Chair of the Association of Police Authorities.

Decision

- **confirmed** its commitment to a membership scheme for PCCS;
- **agreed** that the proposals in the draft prospectus should be shared more widely.
