## 1. LGA Work Programme – cross-cutting themes

David Williams (Programme Director) introduced the capping paper and explained that there was a renewed emphasis on Members and officers engaging in joined-up working between boards. Cllr Sir David Williams (Vice Chair, Improvement Board) set the context for wider discussion, explaining that the DCLG White Paper presented an opportunity for the LGA, through its Boards, to shape the improvement agenda. Boards had a key role to play in offering views on the and in identifying and tackling under-performance.

In discussion on cross-cutting themes, the Board noted the importance, in addition to those areas set out in the papers presented, of a Safer Communities input into work on place-shaping and on licensing/gambling issues. There was a role for Board champions to take forward individual cross-cutting issues and to lead interaction with other LGA policy boards; there was also a role for cross-cutting task groups with membership

drawn from a number of boards. On questions of performance improvement, the Board discussed challenges in, and approaches to, gaining an understanding of levels of performance in councils and partnerships; of reflecting into LGA discussions the experience and concerns of frontline councillors; and of spreading out to elected Members in councils, headline messages for the sector as a whole.

## **Decisions**

The Board reconfirmed the importance it attached to the role of individual Member champions and to develop their role in terms of interaction with other policy boards.

The Board also agreed to contribute to the performance and improvement challenges facing the sector as outlined in the paper for discussion.

#### Action

Officers to circulate a list of current Board champions and to work with office holders and individual champions to develop a 'job description' for these roles. .

Officers to facilitate improved awareness of work undertaken by other LGA boards; and to frame as far as practicable work on the Safer Communities Board interventions around the cross-cutting themes of Performance and Improvement, Governance, Place Shaping, Transforming Public Services, Community Cohesion and Resources for the remainder of the policy cycle.

## 2. Domestic Violence Project – final report and presentation

The Board welcomed Anthony Wills (Chief Executive) of Standing Together against Domestic Violence to the meeting.

Anthony Wills gave a presentation setting out what had been achieved by the LGA's domestic violence project He illustrated the significance of domestic violence both in

terms of its impact on society, on families and children and cost to the economy locally and nationally. The Board discussed the need for local authorities to continue play a leading role in combating domestic violence. The need for a co-ordinated and 'mainstreamed' community response was emphasised. Discussion also centred around questions of funding, partnership working and how best to measure the effectiveness of policies and practices in this area.

# **Decisions**

The Board approved the final report and conclusions and agreed that the project's achievement should be exploited by the LGA, in conjunction with the IDeA, to ensure that examples of best practice are widely shared and continue to inform community safety and other areas of policy development, including safeguarding children and housing. Councillor Hazel Harding thanked Councillor Ann Lucas, Anthony Wills and colleagues for all of their work on the domestic violence report.

#### **Action**

Officers to take forward the good work achieved, in conjunction with the IDeA, in order to maintain contact with networks of practitioners and advisers and to continue to support Councillor Ann Lucas in her role as domestic violence champion.

Councillor Ann Lucas and David Williams (Programme Director) updated the Board on the LGA's response to the serial murders in Ipswich in December. The LGA had liaised with councils in Ipswich and Suffolk to offer any help that was required. The murders raised the profile of policies and attitudes towards prostitution, and this has provided an opportunity to look, with central government, at the policy framework surrounding this issue. There would also be benefit in drawing out lessons for the preparedness of councils to deal with incidents of this sort.
