# Item Decisions and actions Action

#### 1 Declarations of Interest

The Chair welcomed and introduced members to the Resources Board meeting.

No declarations of interest were made.

# 2 Local Government Finance Update

The Chair invited Nicola Morton, Head of Local Government Finance, to present the report which provided a summary of the work by the LGA on funding and finance issues since the previous meeting.

Since the circulation of the agenda, the government had published an Online Sales Tax consultation which officers were working on providing a response.

Members discussed the report and asked questions of clarification.

In response to concerns raised over the practicalities of billing authorities delivering Council Tax Energy Rebate for 2022/23, Members were advised that the LGA had been liaising with the government on the issues raised. Members requested the link to the guidance and funding allocations, published on 23 February 2022, be circulated to them.

It was agreed that discussions relating to pensions would take place in the private session of the Board meeting, following item 5.

- Officers to circulate the guidance and allocations for council tax billing authorities on the £150 Council Tax Energy Rebate, and allocation for the £144 million discretionary fund to Board Members
- Officers to circulate the report from WPI Economics assessing certain options for local government finance reform to Board Members

# 3 Update on Local Audit

The Chair invited Bevis Ingram, Senior Adviser, to present the report which provided an update on local audit and outlined major reviews and other activity that had been undertaken in the previous three years.

Members discussed the report and expressed concerns over considerations to make the independent member a statutory requirement. Councils had previously found securing an independent member for their audit committees difficult.

In response, Bevis Ingram advised that the Chartered Institute of Public Finance and Accountancy (CIPFA) had committed to publishing guidance on audit committees in April 2022.

# 4 Review of CIPFA Prudential Code and Treasury Management Code

The Chair invited Bevis Ingram, Senior Adviser, to present the report which provided a summary of reviews of the final published versions of the CIPFA prudential code and Treasury Management Code following concerns raised at a previous meeting of the Board.

Members commented that they were reassured by the revised code.

The Chair thanked Members of the Board and Officers for their work.

# 5 Support for Low Income Households

The Chair invited Rose Doran, Senior Adviser, to provide an update on the LGA's work delivered to support councils and shape policy on support for low-income households. Much of the improvement work had been more reactive in response to the impacts of Covid-19 and would now be more proactive.

Members discussed the report and expressed concerns that the events in Ukraine would contribute to the cost-of-living crisis. Following clarifying questions, Members were advised that the Cost-of-Living Steering Group was set up to be deliberately broad so that housing, children's services, adult social care, and other areas could be covered within it.

Additional Information under Pensions in Finance Update

# Ukraine

1. Any LGPS authorities who are not already doing so have been advised to consider the implications for their investment portfolios in the light of events in Ukraine and resultant extant and potential sanctions by the UK government are advised to and discuss with their pools and asset managers what action should prudently be taken.

# Investing in line with UK foreign and defence policy

- 2. On 22<sup>nd</sup> February an amendment to the Public Service Pensions and Judicial Offices Bill will provide powers for the Secretary of State to produce directions and guidance in respect of investment decisions which are not 'proper for the scheme manager' (LGPS authority) 'to make in light of UK foreign and defence policy.'
- 3. On 24<sup>th</sup> February LGA officers met with HM Treasury and DLUC officials to clarify the government's intentions regarding this power. The meeting was helpful however there remains a very real concern that the wording of any direction or guidance could inadvertently restrict the ability of LGPS authorities to take proper and prudent account of Environmental, Social and Governance (ESG) matters in their investment decisions.
- 4. It is therefore proposed to seek assurance from government that the power would not be used to restrict the proper account of ESG matters when the Bill returns to the Lords for consideration of amendments. Timetabled for w/c 7<sup>th</sup> March
