Item Decisions and actions

1 Welcome, Apologies and Substitutes, Declarations of Interest

The Chair welcomed Members, officers and guests to the meeting.

Apologies were received by Cllr Hinchcliffe, Cllr Miller and Cllr Kaur. Cllr Bennett, Cllr Cook, Cllr Penberthy and Cllr Dacres attended substitutes.

No declarations of interest were made.

2 Minutes of the last meeting

The minutes of the meeting held on 25 January 2023 were agreed as an accurate record.

3 Theme 1: Future of Cities

Philip Clifford, Senior Adviser, introduced the paper and provided an update on the recent urban summit and an overview of follow-up work.

Members made the following comments:

- A Member suggested that future urban summits be held at a more convenient time for councillors and felt that the recent urban summit was in very close proximity to the local elections, meaning not as many councillors were able to attend. The Chair suggested that future urban summits be held mid to end of February each year.
- The importance of focusing on urban areas more broadly, as opposed to just city-centres, was emphasised.
- A Member highlighted several economic issues regarding smaller urban areas.
- The importance of expanding the list of key stakeholders, their engagement and ensuring that their voices were heard was emphasised.



Decision:

That Members **note** the report.

4 Theme 2: Levelling Up

a) Supporting Economic Inclusion

Bushra Jamil, Adviser, introduced the paper which set out an overview of the six guiding principles to realise economic inclusion in employment and skills, and the key tasks and roles that local government would undertake.

Members made the following comments:

- It was noted that four of the six Economic Inclusion
 Principles set out within the report stated, 'Local
 Government may want to...' as opposed to 'Local
 Government will/shall...'. The need to make the wording
 stronger and clearer was emphasised.
- A Member highlighted the potential negative impact that data collection could have on local authorities and their represented areas.
- In reference to Principle 2, the importance of access to good quality broadband across the country was emphasised.
- In reference to Principle 3, it was suggested that economic growth be included.
- The need for more research and action into the current lack of transport and connectivity across all areas of the country was highlighted.
- A Member felt that there should be more emphasis within the paper on economic opportunity and opportunities through the Voluntary and Community Sector (VCS).
- The importance of investing in infrastructure and retrofitting for future generations was emphasised.

Decision:

That Members **note** the report.

Action/s:

- Officers to check legal history to see if the title wording of four of the six Principles could be strengthened and to update the Board.
- Officers to progress collaborative work with the transport policy team to explore a) how transport challenges could be addressed, and b) how the cost of lack of transport connectivity could be quantified.
- Officers to consider bringing a paper to a future meeting of the Board focused on collaboration and partnership



working.

b) Update on the health and devolution working group with NHS Confederation

Philip Clifford, Senior Adviser, introduced the paper and provided an update on the newly formed health and devolution working group established by NHS Confederation and cosponsored by the LGA following its first meeting in April 2023.

Members made the following comments:

- Cllr Ford, as the Board's representative, had attended a
 recent meeting whereby transport and the impact that a
 lack of access to transport had on health and wellbeing
 had been discussed. The working group had also looked
 at devolved authorities, the issues related to the meaning
 of devolution in different localities and the impact on
 health and wellbeing consequently. She confirmed that
 she would be attended future meeting of the group and
 would continue to feedback to the Board at future Board
 meetings.
- A Member asked a question which related to data-sharing.
 Cllr Ford responded and confirmed that data-sharing would be a key topic of discussion at a newly formed Joint Commissioning unit with health partners.

Officers to feedback Members' comments to the NHS confederation.

5 Theme 3: Urban Resilience

a) Local Resilience Act

The Chair welcomed **Joe Fyans**, Head of Research at Localis, to the meeting and invited him to introduce the report. Joe presented a series of slides which set out information related to the independent think tank, Localis, which explored the potential of a 'local resilience act' to help strengthen local authorities' ability to respond to current and future risks arising from a changing climate.

Members made the following comments:

A Member highlighted challenges related to current



- energy demands across the country, and the significant need for more affordable housing.
- The need to combine adaption with mitigation, and share best practice was expressed.

With regards to the support that the Board could provide to Localis, Joe confirmed that more in-person events and stakeholder engagement would be beneficial.

6 Theme 5: Growth Funding

a) Supporting Economic Growth and Prosperity

Philip Clifford, Senior Adviser, introduced the paper and provided an update on the work of the Board in supporting local economies.

Members made the following comments:

- A Member made a comment which related to the impact of freeports and the way in which they could help the economy.
- The importance of the role of urban areas in driving growth and prosperity was emphasised.
- The need for clarity in relation to the future of LEPs, associated powers and assets was expressed.

b) Growth Funding Update

Philip Clifford, Senior Adviser, introduced the paper and provided an update on recent work to improve the provision of growth funding from national to local government highlighting correspondence with the Secretary of State relating to the Levelling Up Fund.

Paul Green, Adviser, introduced the paper which provided a summary of progress from the Local Capacity and Capability sub-group and proposed a policy narrative for a green jobs framework.

Members commented on the report. Their comments included information related to retrofitting, adaptation, sustainability, the importance of investing in skills and private-sector investment.

Paul responded to Members' comments.

Their comments included information related to the British Chambers of Commerce, culture in local authorities, responsiveness, opportunities, working with partner organisations, the importance of local authorities and the work that they undertake, growth and consolidation.

City Regions Board Terms of Reference

Background

- 1. The LGA's policy boards are asked to review and agree their terms of reference at the beginning of every Board cycle. Board members have made a number of changes to the terms of reference over the lifetime of the Board to reflect the changing policy landscape, for example reflecting the role of urban leaders in climate and net zero issues.
- 2. The City Regions Board provides a forum for urban authorities to debate sustainable economic growth, including the importance of decarbonisation and biodiversity recovery, and public service transformation in their areas. Excluding urban policy, the Board works jointly with the People and Places Board.
- 3. Where our work crosses the remit of other Boards, such as in health devolution, members have worked with their colleagues on the relevant Boards to ensure our work supports the LGA's wider policy objectives while also amplifying the interests of urban authorities. This may result in a joint undertaking or a standalone piece of work, but in all instances LGA officers will work closely together to avoid duplication or confusion of the LGA's policy lines.
- 4. At the LGA Board's July meeting, as part of a portfolio update to some LGA Boards, members agreed that the People and Places and City Regions Boards take on 'strategic transport and housing' as part of their remit. This change is underlined in paragraph 4 below. Discussions with the Local Infrastructure and Net Zero Board (formerly Economy, Environment, Housing and Transport) and People and Places Board to ensure the work programmes are complementary.

Terms of reference

- 5. The purpose of the City Regions Board is to represent the interests of urban areas and city regions, including those which are part of Combined Authorities or seeking devolution deals. Its remit includes devolution, inclusive and sustainable economic growth, skills and employment support, <u>strategic transport and housing issues</u>, wider public service reform. It will also consider the role of urban leaders in responding to the climate and ecological emergencies, working with the Local Infrastructure and Net Zero (LINZ) Board, and the opportunities within the Board's work programme to promote improved health and wellbeing.
- 6. The Board should seek to involve councillors in supporting the delivery of these priorities (through task groups, Special Interest Groups (SIGs), regional networks and other means of wider engagement); essentially operating as the centre of a network connecting to all urban councils and drawing on the expertise of key advisors from the sector. This includes working closely with relevant LGA Boards.
- 7. The City Regions Board's responsibilities include:
 - 7.1. Ensuring the priorities of councils are fed into the business planning process.
 - 7.2. Developing a work programme to deliver the business plan priorities relevant to their brief, covering lobbying campaigns, research, and improvement support in the context of the strategic framework set by Improvement & Innovation Board and events and linking with other boards where appropriate.

- 7.3. Sharing good practice and ideas to stimulate innovation and improvement.

 Representing and lobbying on behalf of the LGA including making public statements on its area of responsibility.
- 7.4. Building and maintaining relationships with key stakeholders.
- 7.5. Involving representatives from councils in its work, through task groups, Commissions, SIGs, regional networks and mechanisms.
- 7.6. Responding to specific issues referred to the Board by one or more member councils or groupings of councils.
- 8. The City Regions Board may:
 - 8.1. Appoint members to relevant outside bodies in accordance with the Political Conventions.
 - 8.2. Appoint member champions from the Board to lead on key issues, with responsibility for liaising with portfolio holders on key issues that require rapid response/contact with councils.

Quorum

9. One third of the members, provided that representatives of at least 2 political groups represented on the body are present.

Financial Implications

- 10. Membership of the City Regions Board is drawn from the Core and Key cities, SIGOMA and London Boroughs, and is reflective of those in Combined Authorities or seeking devolution deals.
- 11. The Board has 22 members and its make-up reflects the political proportionality of the wider group of councils from which the membership is drawn. This differs from the seven policy boards, whose make-up reflects the political proportionality of the Association as a whole.
- 12. The chair has been appointed from the largest group on the Board and falls within the LGA's own proportionate allocations. In line with the LGA's political conventions, the remaining groups each have a vice or deputy chair.
- 13. The composition by political party is recalculated each year and reflects the political proportionality of the wider group of councils from which their membership is draw. The current composition is:
 - 13.1. Conservative group: 4 members
 - 13.2. Labour group: 14 members
 - 13.3. Independent group: 2 members
 - 13.4. Liberal Democrat group: 2 members
- 14. Substitute members from each political group may also be appointed.

Frequency

15. Meetings to be held five times per annum. For the 2023/24 cycle, it is proposed that 3 meetings be held virtually, with two meetings hybrid with members invited to attend in person if possible. Subject to member agreement, these dates will be agreed and circulated shortly to allow for travel planning.

Reporting accountabilities

16. The Board will report annually to the LGA Executive Advisory Board at the July meeting.

City Regions Board Overview and Priorities 2023-24

Background

- The City Regions Board represents the urban members of the LGA. It works in partnership with the non-metropolitan People and Places Board on a number of crosscutting issues such as devolution, local economic growth and skills and employment support.
- 2. In discussing the run up to the next general election in the last Board cycle, members were keen to see progress on the Board's policy priorities and also to see a greater recognition at a national level of the needs and potential of urban areas. This paper contains a brief update on work across the Board's core policy areas and asks for lead members' views on the draft policy priorities agreed at the end of the previous Board cycle.
- Separate papers will update members in more detail on planned activity across our work programme. We would be grateful for members' comments on the overall balance of the work, including any early thoughts on the new inclusion of strategic housing and transport.

Local Government White Paper

- 4. At the annual conference in July, the LGA launched its 'Make it Local' report. The report sets out a range of clear offers from local government in the areas that pollsters are reporting as the biggest issues of concern for the public, and therefore are likely to be prominent in national parties' manifesto proposals. Alongside the LGA's ongoing work to influence party manifestoes, we will be working with the sector to develop more detailed proposals for a new or returning government to implement.
- 5. The Board's existing work programme is well placed to inform the White Paper, and work due to be completed on economic inactivity, health devolution and councils' role in growth and prosperity will be well timed to contribute. Members might wish to reflect on particular issues for urban areas they would like to see covered in the White Paper.

Policy overview

Urban policy and the future of cities

- 6. The LGA's second urban summit was held in March 2023, with over a hundred people attending in person. Attendees heard from Andy Haldane, Chief Executive of the RSA who set out the initial findings of the RSA's UK Urban Futures Commission, including how UK cities lag behind their global competitors on productivity and growth, and highlighted the links between income and health disparities. This was followed by a reception at the LGA's annual conference. The work was supported by a collection of essays, videos, data and analysis on the LGA's Future of Cities Hub.
- 7. The summit was supported by an open letter to Michael Gove, Secretary of State for Levelling Up, Housing and Communities signed by the leaders of Core Cities, Key Cities and London Councils. This set out our ambitious offer to government: that, with the right

policies, finances, and space to deliver, cities can produce better outcomes, not just for urban areas, but also for the whole country. As we look to the next general election, there is an opportunity to sharpen our offer to Government and consider how a third Urban Summit in 2024 could give the Board, and its partner Special Interest Groups, a platform to engage influential people and organisations to amplify this offer.

Growth and prosperity

- 8. The role of local government in local economic growth and prosperity is increasingly seen as critical to supporting the national economy, but more can be done to support councils and devolved areas in their efforts. The People and Places and City Regions Board commissioned WPI Economics to review councils' current roles and responsibilities and put forward recommendations for improvement.
- 9. Earlier this month Government confirmed <u>its decision to withdraw funding to Local Enterprise Partnerships (LEPs) and move their functions to local government</u>, supported by some revenue funding in 2024/25. Government also published its plan to <u>simplify grant funding</u> to local government. We also expect Round 3 of the Levelling Up Fund (LUF) to be announced in the coming months.

Skills and employment support

- 10. The LGA, councils and devolved authorities and partner local government representative bodies are united in their view that the status quo in designing, commissioning, and delivering employment and skills activity needs to change. The sector has a time-limited opportunity to influence all political parties that the LGA's Work Local approach can address the challenges and opportunities faced by people and places, and that it can be implemented across all places over time. A returning Government or new administration will want to adopt policies that it can move forward with at pace and with limited budgets. We need to both work through the operational level detail needed to turn our agreed policy lines into reality, as well as communicate our messages in a clear and simple way.
- 11. We have upcoming research on economic inactivity, one of the biggest labour market challenges, due to be published in the autumn. Officers continue to work with the Departments for Education; Work and Pensions; and Health and Social Care to promote a place-based approach. Following agreement by the previous Board, officers are scoping a piece of work to evidence how the fragmentation of the transport system impacts access to education, training and employment opportunities. Government's working groups on green jobs will put forward their recommendations in the autumn; there are opportunities to undertake work on the workforce needs of delivering low carbon energy security.

Devolution and Levelling Up

12. It is positive that all national parties have signalled a commitment to further devolution to local government. The LGA-sponsored Devolution APPG will continue to promote the opportunities for devolution with Parliamentarians, building on the People and Places and City Regions Boards' Levelling Up Locally Inquiry. The City Regions, Community Wellbeing and People and Places Boards are part of the time limited health and devolution working group established in April 2023 and co-sponsored by NHS

- Confederation and the LGA. It will meet for a final time in September to agree recommendations, which could feed into the LGA's White Paper work.
- 13. The LGA, through its improvement and support work, also works with combined authorities and existing and aspiring devolution areas to support them and share learning and best practice.

Strategic transport and housing

14. As part of a refresh of Board portfolios, the LGA Board agreed that the City Regions and People and Places Boards would take on responsibility for 'strategic housing and transport,' working alongside the new Local Infrastructure and Net Zero Board (formerly Economy, Environment, Housing and Transport). Following a meeting of the City Regions, People and Places and LINZ Chairs, discussions of how to implement this change are ongoing and we hope to bring fuller details to the next meeting of the Board.

Urban resilience

15. Following the record temperatures of summer 2022, Board members were interested in understanding the particular challenges and opportunities for resilience in cities and urban areas. We heard from Bristol City Council about their work on a heat map and how it would inform their work. We also heard from the think tank Localis on their work on 'Reaching Climate Resilience,' a project to examine what statutory provisions would be necessary to empower councils to act on climate resilience through: whole systems resilience; sustained and adequate finance, and subregional governance frameworks. It is proposed that this policy area move forward as a watching brief for 2023/24.

Proposal

- 16. Following a discussion with Lead Members of the Board, the following priorities are proposed, which are based on the draft priorities proposed at the end of the 2023/24 Board cycle:
 - 16.1. Making the case for investment in urban areas and city regions ahead of the upcoming general election within the framework of a more devolved and place-based approach to public services.
 - 16.2. Removing barriers to councils' abilities to support inclusive and sustainable local growth.
 - 16.3. Embedding our Work Local proposals into national policy, including specific policy proposals to support green jobs and net zero.
 - 16.4. To strengthen the case for urban authorities' role in strategic transport and housing (subject to ongoing member discussions).

17. Board members are asked to:

17.1. Agree the above priorities, with the caveat that the final priority may need to be refined at a later meeting.

17.2. Agree the proposal to move forward with urban resilience as a watching brief, particularly in light of the Board's expanded remit.

Implications for Wales

18. Many areas of the Board's policy are devolved, however we undertake to work with the WLGA to share learning as necessary.

Financial implications

19. The work described can be undertaken from within the Board's budget.

Equalities implications

20. The Board has sought to reflect the importance of equality, diversity and inclusion throughout its work programme, including the particular needs of communities in non-metropolitan areas. An equalities champion is due to be centrally appointed to the Board in the autumn.

Health Devolution

Background

- The City Regions Board has a longstanding interest in strengthening the alignment between NHS reform and local authority devolution to improve health outcomes and economic and social development.
- 2. The Board works closely with the LGA's Community Wellbeing Board as they lead the LGA's policy development relating to the integration of health and care, the transformation of the health and care landscape, and the rollout of Integrated Care Systems (ICSs) and health devolution. Previous City Regions Board meetings have been attended by officers from the Community Wellbeing Board providing updates on their work and priorities.
- 3. A key organisation to engage with as part of this work is the NHS Confederation. As the NHS membership organisation, it brings together, supports, and speaks for healthcare bodies in England, Wales and Northern Ireland and leads on how ICSs and the NHS can support economic growth.

Health and devolution working group

- 4. In March 2023 the NHS Confederation established a time-limited health and devolution working group, in partnership with the LGA. The aim of the group is to understand the priorities, opportunities, and challenges for ICS leaders, how this intersects with English devolution to date and the emerging devolution deals to create a system that allows for devolution deal areas and ICSs to build a partnership together. The three LGA policy boards with an interest in this work the People and Places Board, City Regions Board, and the Community Wellbeing Board are all represented on the working group. The LGA's Deputy Chief Executive, Sarah Pickup, sits on it too.
- 5. The group is co-chaired by Sir Richard Leese, Chair of the Greater Manchester Integrated Care Board (ICB) and Dr Kathy McLean, Chair of the Nottingham and Nottinghamshire ICB and Integrated Care Partnership (ICP). Its membership comprises organisations including NHS Confederation, LGA, combined authorities, public health leaders in councils, representatives from DLUHC and DHSC.



- 6. To date the group has met four times and considered the following areas:
 - Place How combined authorities and ICPs can support and enhance subsidiarity, integration and population health approaches at place level
 - Paraphernalia The tools, resources and approaches that local partners can use to unlock greater system working
 - Practice Highlighting where local partners are successfully collaborating to support their communities
 - Partnerships How ICSs should engage locally and nationally
 - Policy How to highlight devolution policy areas that directly and indirectly intersect with ICS roles and responsibilities
 - Process How combined authorities and ICSs can jointly develop or align more closely their governance and accountability arrangements.
- 7. Officers are now drafting a report highlighting emerging best practice and learning from the working group discussions. They will also develop a set of recommendations for politicians and officials to consider how to drive shared outcomes for places at a local level and the powers and resources required. Officers will bring a draft version of the report to the November meeting for discussion with City Regions Board Members.

Proposals

- 8. Members are asked to give a steer on the proposed actions:
 - Michael Wood, Head of Health Economic Partnerships at NHS Confederation attends the November City Regions Board meeting for a discussion with Members about the progress of the health and devolution working group and emerging recommendations.
 - Officers develop and bring a plan to the November Board meeting around the
 publication and launch of the final report and recommendations. This might
 involve organising a launch event in collaboration with NHS Confederation and
 developing a stakeholder engagement plan that identifies key politicians, officials
 and wider organisations whom the Board might like to engage with to land the
 recommendations.
 - The recommendations are used to shape a panel session at the City Regions Board 2024 Urban Summit event. This will be an opportunity for the Board to influence key policymakers ahead of the next general election.

Urban Summit

Background

- 1. The LGA's second urban summit was held in March 2023, with over a hundred people in attendance. Attendees heard from Andy Haldane, Chief Executive of the RSA, who set out the initial findings of the RSA's UK Urban Futures Commission, including how UK cities lag their global competitors on productivity and growth, and highlighted the links between income and health disparities. This work was supported by a collection of essays, videos, data and analysis on the LGA's Future of Cities Hub.
- 2. The summit was supported by an <u>open letter to Michael Gove</u>, Secretary of State for Levelling Up, Housing and Communities signed by the leaders of Core Cities, Key Cities and London Councils. This set out our ambitious offer to government: that, with the right policies, finances and space to deliver, cities can produce better outcomes, not just for urban areas, but also for the whole country.
- 3. As we look to the next general election, there is an opportunity to sharpen our offer to government and consider how a third Urban Summit in 2024 could give the Board, and its partner Special Interest Groups, a platform to engage influential people and organisations to amplify this offer.

Proposal

- 4. Following discussion with City Regions Board Lead Members, we would like to test appetite with the Board on organising a third urban summit to take place in 2024.
- 5. Previous urban summits have brought together city leaders, experts, as well as other stakeholders and partners to draw on their understanding of how cities need to change to meet the needs of the future and the strong offer cities can make to some of the important challenges facing the nation.
- 6. It is proposed that an urban summit in 2024 would have a different focus, providing an opportunity for urban leaders to come together to reach an agreed set of asks and offers around the future of cities, inform the LGA's lobbying to government and political parties in the lead up to the general election, and, crucially, offer a chance to engage with and influence key national decision makers and politicians who could.
- 7. Previous urban summits have been organised in collaboration with Core Cities, and other partners including Key Cities, London Councils, and the RSA. Officers have held early conversations with Core Cities, Key Cities and London Councils to gauge interest in organising and participating in another summit. Feedback has been positive, all are keen to play an active role.
- 8. Following direction from Lead Members, it is proposed that officers start planning for an urban summit be held in person at the end of the board cycle, in June 2024. This would provide an opportunity to bring together the work of the Board from the year, and to avoid clashes with local elections and budget setting. We are open to suggestions about the location of the summit.

- 9. Officers have drawn up options for themes for the summit and possible workshops. We are keen to hear views from members on this and for further suggestions.
 - 9.1. Political parties' perspective on how cities can thrive
 - 9.2. The relationship between cities and towns
 - 9.3. The future of growth funding
 - 9.4. Al and the potential impact on cities' labour markets
 - 9.5. The international perspective on climate action
 - 9.6. The opportunities to align health and local government devolution
- 10. It is intended that the summit be interactive and include urban Special Interest Groups, as well as national agencies and representatives from political parties.

Implications for Wales

11. This work is being carried out within the context of the Levelling Up White Paper, which presents a vision for the UK. While many of the investment and policy levers are likely different within the Welsh context there will be value in drawing on the experience of Welsh cities and the aspirations of Welsh city leaders as part of this work.

Financial Implications

12. The cost of arranging an urban summit as well as any additional policy activity arising from this paper will be met from the Board's policy and research budget.

Equalities implications

13. Officers will ensure that the urban summit has a diverse range of speakers which reflects the diversity of cities in the UK, and that equalities implications of policies affecting cities are examined as part of the sessions taking place in the urban summit.

Next steps

14. Subject to feedback from members, officers will agree a date and agenda for the urban summit and bring this to the Board for agreement.
