#### Item Decisions and actions

## 1 Welcome, Apologies and Substitutes, Declarations of Interest

The Chair welcomed Members, officers and guests to the meeting.

Apologies were received by Cllrs Lepoidevin, Robinson and Miller. Cllr Turrell attended the meeting as a substitute.

No declarations of interest were received.

## 2 Minutes of the last meeting

The Chair welcomed Members, officers and guests to the meeting.

#### 3 City Regions Board visit to Manchester - agenda

The information contained within this agenda item was noted without discussion.

#### 4 Universal Support

The Chair invited **Jasbir Jhas**, **Senior Adviser**, to introduce the report. Positive early discussions had taken place between the LGA, councils and the Department for Work and Pensions (DWP) on plans to route Universal Support, a major new employment support programme, through local government. The report updated Members on progress to date and next steps. A Work Local update was also provided. A similar discussion took place at the People and Places Board on Tuesday 23 January.



Members made a number of contributions, which related to the following points:

- The importance of supporting care leavers into employment
- Incentivising employers through marketing
- Capacity building
- Good opportunities for local government
- Transitions from old technologies to new
- Green skills agenda and training opportunities
- Flexibility to meet various needs
- Building upon current good practice
- Clustering and lobbying government
- Voluntary schemes
- Comparative examples for best practice sharing and lobbying purposes
- Barriers to employment a lack of transport connections
- Capacity and next steps

Jas responded to Members comments and thanked them for their contributions.

#### 5 Presentations from partners

a) Jason Prince, Director, Urban Transport Group

The Chair welcomed **Jason Prince**, **Director of Urban Transport Group**, to the meeting and invited him to present a series of slides to the Board. The slides set out:

- Urban Transport Group background information
- Case studies and productive policy
- Thought leadership and strong relationships
- Advocates for public transport
- Professional network
- Key challenges facing Urban Transport
- · Active Travel and Future Mobility

Members made the following contributions:

- The importance of maximising the benefits of transport modes was emphasised.
- A question was asked which related to bus funding and associated research to assist with making a case to government.
- The need to focus on geographical impacts in relation to additional costs associated with travel, the economy and links into cities, was expressed.



 It was suggested that councillors be more involved in Urban Transport Group meetings to provide greater insight into the transport-related challenges that residents face.

Jason responded to Members' comments and questions and thanked them for their contributions. He emphasised the importance of investment into transport to create better places and outcomes and to have a clear identity of the country's direction economically, socially and in achieving decarbonisation targets.

b) Henri Murison, Chief Executive, Northern Powerhouse Partnership

The Chair welcomed **Henri Murison**, **Chief Executive**, **Northern Powerhouse Partnership**, to the meeting and invited him to address the Board. He provided background information related to the work of the Northern Powerhouse Partnership, in addition to:

- The need to bring together a wider coalition of voices to make a strong case to government for vital transformation transport investments.
- The lack of funding for local government and its reliance on government deploying money fairly and sensibly.
- The demographic change which enabled people to work in their nearest large city and commute from outer lying areas.
- The role of transport and its importance to a sustainable economy.
- Current transport barriers.
- Government decision making and its challenges.

Members made the following contributions:

- Capacity issues related to the HS2 railway line were highlighted. The importance of tackling the management structure of the railway system was emphasised.
- A question was asked which related to the specific changes required to allow the structural roll out to progress at a faster rate.
- A concern was raised regarding uncertainty.
- A question was asked which related to the Board's main focuses over the next year.

Henri responded to Members' comments and questions and thanked them for their contributions.

- c) Cllr Bev Craig, Leader, Manchester City Council

The Chair welcomed **CIIr Bev Craig**, **Leader**, **Manchester City Council**, to the meeting and invited her to address the Board. She provided information which related to the following:

- The close working relationship with the Northern Powerhouse Partnership.
- The importance of transport in attracting businesses and economic growth.
- Work being undertaken which related to the economic strategy and analysis to tackle urban inequality.
- The lack of government support in tackling transportrelated issues.
- Views from businesses about the lack of reliable transport links and the value that they would bring.
- The ability to connect buses with trams and, in time, regional rails.
- Next steps for Manchester's transport policy.

Members raised concerns which related to the structural and systemic barriers regarding transport, the gap in social and economic aspirations and the lack of connectivity and its impact on economies and house prices.

Cllr Craig responded to Members' comments and questions and thanked them for their contributions.

## 6 Support for care leavers

The Chair invited **Megan Edwards, Adviser**, to present the report. The Chair of the LGA, Cllr Shaun Davies, had announced that one of his priorities for 2023-24 is corporate parenting, in particular support for care leavers. Recognising that all Councillors are corporate parents to children in care and care leavers, all policy Boards were asked to share their own ideas for this priority area, to shape the LGA's work in relation to supporting care leavers. The report outlined current ideas for the programme and next steps.

Members made the following contributions:

- Many examples of good practice within local government were shared.
- The importance of care experience being treated as a protected characteristic, including by other public bodies, was emphasised.



- The importance of wrap-around and transitional support for care leavers was recognised.
- The need to work closely with partners, local charities and voluntary groups in relation to young people in care/care leavers to share best practice, was expressed.
- The importance of ensuring that all young people had access to basic life skills programmes to ensure self-sufficiency after leaving care, was emphasised.
- The need for appropriate funding to support care leavers who were formerly unaccompanied asylum-seeking children was raised.
- The need for additional support within the workplace for care leavers was expressed.

## **Strategic Housing Discussion**

## **Background**

1. As part of the new Strategic Housing policy remit of the Board, Lead Members agreed that this session should be themed on strategic housing. This session will explore city regions housing needs relating to older people housing, housing development and estate renewal.

## **Older People Housing**

2. **CIIr James Jamieson OBE**, is a member of the Government <u>Older People's Housing Taskforce</u>, which was launched in May 2023 to look at options for the provision of greater choice, quality and security of housing for older people. Cllr Jamieson will attend the meeting to update members on the Taskforce's emerging findings and members will have the opportunity to influence its recommendations. He will be providing his view of representing local government and will not be formally representing the views of the taskforce.

## **Building communities through housing regeneration**

3. Gary Orr, Chief Executive of the Abri Group. Abri Housing Association have a good track record of working with local authorities in delivering housing for urban communities, including coastal communities. This will be an opportunity for members to consider issues relating to housing needs in city regions, and how local authorities can develop strong partnerships with housing associations.

## **Building communities through estate renewal**

4. Jordan Rosenhaus, CEO and Andrew Shepperd, Managing Director, TopHat. Top Hat will be presenting how estate renewal can be undertaken to support wider local place based goals, such as skills/jobs development, delivering carbon neutrality and local business benefits.

## Implications for Wales

5. Any future policy priorities established by the Board and any learning from the presentations can be shared with the Welsh Local Government Association.

## **Financial Implications**

6. This programme will be delivered within existing budgets.

## **Equalities implications**

- 7. Older people are directly impacted by housing demand, and the Board will consider the challenges of delivering suitable housing in city regions for older people, especially in supporting independence and reducing social isolation.
- 8. A <u>number of protected groups</u> and people who experience disadvantage are more likely to present themselves homeless, be overrepresented on housing waiting lists or have specific housing needs. This includes, young people, people with young children, care leavers, disabled people, veterans, particular black and minority ethnic communities and young lesbian, gay, bisexual and transgender people. By delivering local authorities' strategic housing ambitions, some of the inequalities to access housing can be addressed.

## **Next steps**

9. Feedback from the Board today will be taken forward by LGA officers to deliver any future work to support policy priorities related to strategic housing.

#### **Health Devolution**

Officers have continued to work with the NHS Confederation on a joint report into the
opportunities for closer working between Integrated Care Systems and local government
devolution. Following feedback from members a shorter, more focused report is being
written and will be circulated to lead members of the People and Places, City Regions
and Community Wellbeing Boards for comment and clearance before publication.

## **Universal Support**

- 2. The LGA is working with DWP to route Universal Support (US), the Government's Back to Work intervention announced during last year's fiscal events, through local government. The £1.4 billion 'place and train' employment programme covering England and Wales, will support economically inactive groups including those with physical and mental health conditions and unemployed people with complex needs. It will be phased in from Autumn 2024 and run to 2028/2029. We continue to bring councils together with DWP to discuss design elements and are linked in with devolved areas who are having parallel discussions.
- 3. Board Members discussed this at the January Boards and raised several points. These included: US and similar initiatives being led by Integrated Care Boards must align; local government needs the ability to move funding from year to year; some groups will take longer to secure sustained employment; and training is vital to help people transitioning to new industries.
- 4. Political level engagement between the LGA and DWP is critical to ensuring a shared understanding and commitment to delivering this. We will report back to the Board following a meeting with Mims Davies MP, the Minister for Disabled People, Health and Work.

## **Strategic Transport**

5. City Regions Lead Members have agreed to lead on the commissioning of a piece of work looking at examples of decision-making arrangements for transport investment and planning in different countries, including the UK, and the role of local governments within them. The research will consider how well transport decisions are being integrated with other infrastructure and service decisions and include consideration of the specific needs and experiences of urban and non-metropolitan places. This comparison will allow a robust appraisal of the strengths and weaknesses of the current system in England together with options for change to strengthen our evidence base for any changes we wish to propose to a new or returning government. Given the People and Places Board's shared interest in this work officers will work with Lead Members of that Board to ensure that their priorities and ambitions are captured and reflected in this project.

#### **Green Jobs**

6. The LGA has been collaborating with other local government sector bodies, including ADEPT, MCA Network and UK100, as part of the Local Capacity and Capability subgroup in putting forward a vision for the skills and net zero system, reflective of the LGA's Green Jobs Framework. This has also been informed by the views of representatives of

businesses, skills providers and industry. The local government representative will continue to promote this model through the Ministerial Green Jobs Delivery Group, with an expected Green Jobs Action Plan due later in March 2024

## **Implications for Wales**

7. Officers will look to share lessons emerging from this work with the Welsh Local Government Association when appropriate.

## **Financial Implications**

8. This can be met from the Board's budget.

9. When possible, LGA officials will include details related to inequalities, including protected characteristics and other groups that experience.

## **Next steps**

10. Officers will continue driving work forward and will report back to the Board when appropriate.
