# **Background**

- 1. Following a discussion at the CTS Board meeting on 16 March 2022, members agreed that the 2022 CTS conference would be held as a hybrid event in the autumn.
- 2. This will be held at the LGA conference facilities at 18 Smith Square, London, giving us access to our own hybrid meeting technology and maximum flexibility should we need to adapt the conference format at short notice.
- Given the hybrid nature of this year's conference, it was agreed that the walking tour and dinner, the latter of which were subsidised by the host council in previous CTS conferences, will not take place in 2022, but will return in 2023.
- 4. To make up for the lack of a walking tour at the CTS annual conference we are running a walking tour of Harrogate's heritage assets at the LGA Annual conference on Wednesday 24<sup>th</sup> June. We plan to hold the walking tour prior to the CTS session on "Heritage and the visitor economy: how can local heritage contribute to our economic recovery?", which will complement the session and bring it to life.
- 5. The theme of this year's conference will focus on recovery in the context of levelling up and tackling inequalities.
- 6. The conference will run over one day from 10.30 to 15.30 on Tuesday 11<sup>th</sup> October. This date takes into account the political group conference season and the October half term.
- 7. The October date has been selected allow for more time between the political group conferences and the CTS conference. We anticipate that this will result in a stronger attendance rate. Please note that this date falls into the next Board cycle.
- 8. The conference format will include a mixture of keynote, panel, and workshop sessions highlighting good practice from all three policy areas.
- 9. In previous years, the CTS annual conference has been held in March. However, the delay to the 2022 event means that this would mean two conferences in the same financial year which could have implications for the LGA and delegates. Any early views from members on the timings for next year's conference would be welcome.

# **Implications for Wales**

11. Welsh authorities are eligible to register for the conference at the same rate as English member councils.

## Implications for inclusion, diversity and equality

- 12. All councils now have established online communications technology, but many have travel bans in place and staff who are reluctant to travel, some of whom will have medical conditions making them particularly susceptible to Covid-19. A hybrid event will ensure the widest possible accessibility level for council officers, who typically make up around two-thirds of attendees.
- 13. A diverse range of speakers will be identified, ensuring a variety of perspectives and experiences are heard, and demonstrating a range of leadership roles.

#### **Financial implications**

- 14. Costs for the event will need to be covered by delegate fees. Hosting the conference at Smith Square for this year allows us to keep costs down to around £4,000, not including speaker expenses or other incidental costs.
- 15. The table below sets out ticket prices for the conference in line with the LGA's charging policy. Note that while there is still a cost to attend online/virtually, this conference will offer a full day's programme rather than a shorter one-off session as previously proposed, giving attendees greater value for money.
